European Commissioner Elżbieta Bieńkowska appoints High Level Forum members

The new High Level Forum for the Better Functioning of the Food Supply Chain will assist the EU Commission to develop the European industrial policy in the agrofood sector. Next to high level representatives from all 28 EU Member States, a series of representatives have been appointed to this forum, which is set up until 2019.

For the dairy industry, EDA chair Michel Nalet has accepted to be a member of this group.

This appointment highlights our overall EDA strategy to better reflect in our work the new set up of the EU Commission and to shape the frameworks our industry is operating in. The first preparatory meeting ('sherpa meeting') is scheduled for 18 February 2016.

Agricultural Market Task Force is now operational

As announced at the special Council meeting of the agricultural ministers back on 07 September 2015, **EU Commissioner Phil Hogan** established the Agricultural Market Task Force. This group of 12 eminent market experts, chaired by the former Dutch minister for agriculture, Mr Cees P. Veerman, is called to elaborate ideas for improving the market transparency, the position of farmers in the food chain and the legal possibilities for organising farmers' collective actions, by the end of 2016.

New School Food Scheme: the next steps before 2017

The trilogue agreements on School Food Schemes adopted in COMAGRI on 11 January 2016 should be voted in the EP Plenary in March or April before approval at first reading from the Council. Further to this ratification, the Commission will work on implementing and delegated acts.

Plain milk remains the core product of the School Milk Scheme even though other products like cheese and yogurts are now eligible subject to the approval of national health authorities. 100 M€ will be divided amongst EU Member states that will individually decide the amount of subsidy for some products. While waiting for the new scheme to enter into force in 2017, Member

States should communicate their new strategy under the current scheme by July 2016.

New rules on infant and follow-on formulae expected to be formally adopted soon

On 14 January the ENVI Committee has rejected the objections to the two Commission delegated acts on infant and follow-on formula as well as on foods for special medical purposes (FSMPs). By that the new rules on infant and follow-on formula and FSMPs should be adopted and published soon in the Official Journal of the EU.

The ENVI Committee has however objected the delegated act on processed cereal-based food and baby food. The background of this objection was the sugar content in baby foods proposed (i.e. 30 % of the energy to be provided by sugar). Following the opinion of the ENVI Committee, the European Parliament has rejected this draft delegated act in the plenary vote on 20 January. The Commission will now need to re-draft the text, taking the MEPs concerns on sugar into account. The Commission might seek further scientific advice from EFSA on the nutritional composition of processed cereal-based food and baby food.
